Goffstown man indicted for secretly taping a conversation

◆Grand jury: Another man indicted in eBay scam.

MANCHESTER — A Goffstown man involved in ongoing disputes with school officials and police has been indicted for secretly taping a conversation and distributing the conversation on a compact disc.

The Hillsborough County grand jury returned three indictments against Gerard Beloin, 49, of 45 Tucker Mill Road, Goffstown, alleging he violated the wiretapping and eavesdropping law, a felony that carries a possible $3\frac{1}{2}$ - to 7-year sentence.

At an April hearing in a civil lawsuit, Beloin told the judge a conversation with his landlord, John Janigan, proves certain individuals in Goffstown were seeking to harm him. Janigan owns the New Boston building where Beloin has his offices.

The indictments allege Beloin intentionally disclosed contents of a conversation with Janigan to County Attorney Marguerite Wageling; to James DeHart, deputy general counsel of the state Supreme Court's Attorney

Discipline Board; and to five members of the New Boston School board, Paul Scopa, Marti Wolf, James Neefe, Audry Schneider and David L. Smith.

Beloin has been accusing Goffstown school officials of improprieties since his company, Bluestone Inc., lost the bid several years ago to re-roof Goffstown High School.

He alleges the roofing job done by another contractor doesn't meet codes and cost far more than it should have. The target of his grievances has been Kerry Steckowych, the Goffstown police prosecutor who was then chairman of the Goffstown School Board.

Reached by telephone yesterday, Beloin said Janigan told him if he didn't shut up about Steckowych, Goffstown police will "shoot you dead."

Beloin said he considers this a death threat. He said authorities won't investigate this or the look into his complaints about the roofing project.

In other indictments returned this month, a city man was indicted for theft for allegedly duping three eBay customers who thought they were buying cars from him over the Internet auction service. Mark E. Griffin, 41, of 170 Amherst St. is charged with three class A felony counts of theft by deception, each carrying possible prison terms of 7½ to 15 years, for selling non-existent vehicles.

The indictments say William Hess sent Griffin a \$1,211 check, Mike Maahs sent him a \$6,500 check and Katherine Cluka sent him a \$4,600 check. Griffin allegedly cashed the checks and failed to deliver any vehicles.

Craig Stoklosa, 32, of 86 School St. was indicted on five counts of aggravated felonious sexual assault — crimes that carry prison sentences of 10 to 20 years — involving a female victim under the age of 13. He was also indicted on two counts of felonious sexual assault and charged with two misdemeanor counts of endangering the welfare of a child, for allegedly showing her a pornographic movie and Internet pornography.

Ailene Moody, 28, and Joshua Harrison, 22, both of 209 Pine St., were indicted for theft of lost or mislaid property. They are accused of trying to pawn an \$8,000 mandolin that belonged to a musician.
