DEFENDANT'S 7th MOTION TO DISMISS

NOW COMES Gerard Beloin, Pro Se and hereby moves this honorable Court to DISMISS the indictments against him again, with prejudice, for a second time, because the Prosecution has failed to respond to this Defendants 5th Motion to Dismiss filed on April 6, 2007 by the required date of April 16, 2007. Since the Prosecution has Defaulted on this Defendant's 5th Motion to Dismiss and this is the 4th time they have Defaulted it is obvious that the Prosecution has seen the light and has decided to start obeying the law instead of violating it. Anything less than a second dismissal with prejudice will continue to show extreme prejudice by this Court in favor of the Prosecution and will reach the level of harassment by this Court and the Prosecution.

Attached are recordings of Mr. John Janigan, acting as Prosecutor Kerry Steckowych's "personal messenger" describing how "these guys" go about poisoning whistleblowers that speak out against them.

EXHIBIT A – Recordings of how they murdered Dr. Hieber

John Janigan: "Now were there any bombs, little, something about this size in the house left behind? They have bombs with gas in it. They throw them through windows if they can't get in."

He goes on to describe how "They use the emergency rooms of local hospitals to finish off the target after they sicken them. They are sickened at a time that their emergency room Doctor is on duty. When the target arrives by ambulance, they finish off the target by administering a shot of potassium salt that stops the heart and leaves no trace. So instead of having the standard murder investigation of a person dying unexpectedly and mysteriously in their homes, they have a wrongful death lawsuit filed against the hospital where lawyers reap the benefits of the litigation." This is precisely what happened in Dr. Hieber's case. All of the circumstantial evidence I have collected reinforces the statements made by Mr. Janigan. I will start turning over this evidence to the first prosecutor that starts making arrests of the real criminals in this case for solicitation for murder.

In this particular case the Goffstown PD had jurisdiction over the investigation into Dr. Hieber's death. These recordings are very clear that it is members of the Goffstown PD, Prosecutor Kerry Steckowych is named, that murdered Dr. Hieber by "getting rid of him" for blowing the whistle on the theft of millions in local, State and Federal Education funding money. The recordings clearly show that they plan on doing the same to me. Other recordings have Mr. Janigan telling me that it is the "Chief" that set the arson fire that destroyed the building next to mine as a warning to stop blowing the whistle on their crimes.

I have a Guardian Angel that has been keeping me two steps ahead of these criminals masquerading as law enforcement officers. This Guardian Angel has recently informed me that efforts are under way to make sure that I don't make it to my November 26th trial date. I will be "taken out" by a subtle poison designed to cause a heart attack or a stroke or by a "hunting accident" while on one of my frequent long runs through rural areas. My Guardian Angel has informed me that "the Prosecution is waiting for organized crime to do their jobs so that they won't have to do theirs."

The motive for Mr. Janigan's extortion tactics, admitted to on tape, is to get his \$100,000,000 development project off of the ground, a project that has been stalled by the Goffstown Zoning Board for 7 years. The Chairman of the Goffstown Zoning Board is Attorney Anthony Marts, a "close personal friend" of Prosecutor Kerry Steckowych. He was told that if he delivered the message of death to me that they would grant him his illegal easements.

WHEREFORE, Defendant respectfully requests the following relief:

- A. That this Court dismisses the indictments, again, with prejudice, for a second time, based on the fact that the Prosecution has Defaulted 4 times already.
- B. That this Court dismisses this case with prejudice because of malicious prosecution by Prosecutor Ouellet who is taking the side of organized criminals masquerading as her fellow Prosecutors, organized criminals masquerading as police officers and members of organized crime masquerading as members of the NH Bar Association.

- C. That the Court recommend that Prosecutor Ouellet be prosecuted for malicious prosecution for ignoring hard proof of solicitation of murder by Mr. Janigan, members of the Goffstown PD and their associates claiming that "If I don't shut up I could end up like Jimmy Hoffa." Just to remind the Court, Jimmy Hoffa was a popular and well known President of the Teamsters Union that disappeared in 1975. His body has never been found.
