ADDENDUM TO MOTIONS FOR SUMMARY JUDGEMENT AND CHANGE IN VENUE
SYNOPSIS

This ADDENDUM is designed to simplify and summarize this complicated and convoluted case that is before this court. All of my previously filed motions containing hundreds of pages of detailed evidence connect the dots. This MOTION exposes the framework of how and why “**these guys**”, members of organized crime, get away with these crimes and their connection to the St. Lawrence Parish.

The recordings connect the same prominent and controlling members of the St. Lawrence Parish that have accused me of these crimes to the crimes of **arson, extortion, racketeering, grand theft larceny, perjury and murder**. These crimes were committed to cover up the theft of millions in NH Education tax dollars from the Goffstown High School Construction project. “**These same guys**” are using the St. Lawrence Parish and by proxy the Diocese of Manchester as a front to steal over \$100,000 of the St. Lawrence Parishioners donations. The facts of these two cases are intertwined.

In the Fall and Winter of 2002 and 2003 the Rev. Steven Kucharski of the St. John Neumann Catholic Church in Merrimack, NH stole \$8,000 of the Parish donations. That was a money grab that all parishioners could easily understand. They did not stand for it. He was arrested, tried, convicted and sentenced to prison. **(EXHIBIT A)**

The St. Lawrence Parish donations were stolen in a sophisticated bid-rigging scheme consisting of a Byzantine set of bid specifications that a spokesman for San Francisco City Attorney Dennis Herrera says,

*"Proprietary-specification writing is a new, complex area of construction fraud, Learning about it is at the cutting edge of corruption investigations. **(EXHIBIT B)***

*The learning curve for professionals in the industry, of course, is significantly less steep than for a layperson. Each has spent years mastering his or her trade; **for them, a proprietary spec almost leaps off the page of a construction document.** Law enforcers are faced with having to master the incredibly arcane -- and mind-numbingly dull -- language and mathematical formulas used in specs before they can bring civil or criminal charges to bear, when relevant. **There is nothing like having a whistle-***

blower or two on hand to spot the improprieties masquerading as innocent specifications.

The players in “**The Scam**” (quote from the NJ Report) all have their assignments and come in on cue at the appropriate time. It is well coordinated and scripted by attorneys, right down to the speeches given at the school board meetings. In this case it is the public information session at the end of the St. Lawrence Mass. The machinations involved are identical to the ones chronicled in the movie “The Sting” starring Robert Redford and Paul Neuman. “**Fake**” experts are brought in to bolster their upside down positions. Plants are brought in to say “**amen**” to the leaders at the St. Lawrence Parish Council meetings.

With the evidence of the theft obfuscated by the needlessly Byzantine and convoluted bid specifications, most of the St. Lawrence Parishioners and the public in general will believe a Priest and a Fire Chief when they say, “**This is the cost.**” However, this Court has an obligation to ask the tough questions that arise from the obvious pattern and practice of multiple cases of **perjury, suborning perjury and conspiracy to commit perjury, proven in my motions.** Many of these crimes are being committed by some of the very same people that are falsely accusing me of crimes against the St. Lawrence Parish.

1. In 2002, Goffstown Officials, Prosecutor Kerry Steckowych and Fire Chief Paul Nault, prominent members of the St. Lawrence Parish, co-ordinated a sophisticated bid-rigging scheme that resulted in the theft of millions in NH Education tax dollars from the Goffstown High School Construction project. Goffstown Fire Chief Paul Nault was the controlling legal authority in enforcing the building, structural and safety codes on all public buildings. Goffstown Fire Chief Paul Nault “**looked the other way**” as roofing companies with known ties to organized crime bypassed the legally required and very expensive structural code, building code and safety code upgrades on the Goffstown High School. The contractors were paid, but the work was never done. The evidence I put together was so compelling that when I exposed this sophisticated bid-rigging scheme to the then Chairman of the Goffstown School Board, Dr. Craig Hieber, (a quick study) he took my side. Shortly after he took my side, he dropped dead. Attorney Kerry Steckowych then sent a “**personal messenger to let me know that they had gassed Dr. Hieber and that if I did not shut up, Goffstown Police, on the orders of Goffstown Officials, of which he is one of, would shoot me dead, chop up my body into little pieces and then feed me to the fish in the ocean. I would disappear like Jimmy Hoffa.**” All of this is on tape.

2. On April 21, 2005, in an emergency HEARING at Hillsborough County Superior Court, in the case of Steckowych V Beloin, with Justice Mangones presiding, Attorney Steven Gordon of Shaheen and Gordon stated, under oath, and without equivocation, that all of my allegations had been completely investigated by the NH Attorney Generals Office. He even quoted the Assistant Attorney General of the criminal bureau, **“Will Delker, a close personal friend”** as his source. Subsequent letters from the NH Board of Architects and Engineers show that that statement was completely false, perjurious and designed to gain a favorable ruling from this court. **That is perjury by Attorney Steven Gordon & Prosecutor Steckowych, suborning perjury by Attorneys Gordon & Steckowych and conspiring to commit perjury with Assistant NH Attorney General William Delker (all officers of the court) in order to cover up the admitted crimes of grand theft larceny, extortion, arson, criminal threatening, murder and murder for hire by members of organized crime and a sophisticated racketeering enterprise coordinated by NH Law Enforcement to cover it all up.** All of these crimes are described in detail by Mr. John Janigan, a local developer and **“personal messenger”** to Prosecutor Kerry Steckowych. **“These guys”** are drunk with power. They claim to have committed multiple other murders. **They detail a gruesome murder for hire scheme where they process the dead and dismembered bodies of the victims off of a “f****ing fishing boat in Gloucester, MA.”** It does not get any more crapulent than that. **No one is being investigated or prosecuted for these multiple capital crimes that include recordings of the admission and the method by which they murdered of Dr. Hieber to back up the allegations.**

3. On March 20, 2006, two Peterborough Police Officers stopped me for no reason in the Monadnock Community Hospital parking lot. Several days later they filed a false Police Report stating that I had threatened them with my firearm. Had I actually been threatening two Police Officers with a firearm in a public parking lot, they would and should have arrested me on the spot. After the encounter, Prosecutor Rotman and Prosecutor Steckowych suborned them to file a false Police Report. A felony. Prosecutor Rotman then filed a motion to revoke my second amendment rights based on these two law enforcement officers perjured testimony. When I informed Prosecutor Rotman that I had a crystal clear recording of that encounter he withdrew the motion. **That is suborning perjury by Prosecutors Rotman and Steckowych, perjury by these two Police Officers and conspiring to commit perjury by all those involved. Prosecutor Steckowych knows these two Police Officers personally. No one is being prosecuted for these multiple felony crimes.**

4. On April 24, 2006, at a Goffstown Town Meeting, I spoke out against Goffstown Officials. Prosecutor Rotman then filed a motion to revoke my Second Amendment rights based on witnesses lining up to testify that I had threatened these Goffstown Officials with a firearm at that Goffstown Meeting. After I informed Prosecutor Rotman that I had a crystal clear recording of that entire meeting, he withdrew the motion. **That is suborning perjury by Prosecutor Rotman, perjury by all of these Goffstown Officials and conspiring to commit perjury by all those involved. Prosecutor Steckowych and Chief Nault were present at that meeting. No one is being prosecuted for these multiple felony crimes.**

5. On September 23, 2007, in a letter to the St. Lawrence Parishioners, I informed them of the bid-rigging scheme designed to steal over \$100,000 of their donations. On September 25, 2007, the St. Lawrence Parish and the Diocese of Manchester, through it's Attorneys, filed a letter with this court that included the false claims that I committed the crimes of trespass and criminal threatening by threatening St. Lawrence Parishioners with a gun. **No Police Report. No dates. No times.** One of the witnesses being brought forward is none other than retired Goffstown Fire Chief Paul Nault. Chief Nault is a **"close personal friend"** of prominent St. Lawrence Parishioner, Prosecutor Kerry Steckowych, his tag team partner in coordinating the theft of millions from the Goffstown High School construction project. All of these witnesses are lining up to testify falsely against me. My recordings clearly show that they are perjuring themselves. **That is perjury, suborning perjury, and conspiracy to commit perjury by some of the same Goffstown Officials and Hillsborough County Officials that have committed the same crimes before. No one is being prosecuted for these crimes.** .

This synopsis of the cases against me show a disturbing pattern and practice of politicians, law enforcement officers, attorneys, Goffstown Officials at least one judge and now a priest willing to commit perjury, suborn perjury and conspire to commit perjury in order to violate this respondent's 1st Amendment rights. This is a SLAPP by the legal system to a degree that this country has never seen before. It is unprecedented. It is the controlling reason why my MOTIONS FOR SUMMARY JUDGEMENT should be granted. All of these crimes and the crimes being committed by controlling members of the St Lawrence Parish are not being investigated while I'm being sued and harassed simply for dialing 911. In all of these cases, the facts are intertwined.

The controlling members of the St. Lawrence Parish, the Diocese of Manchester and its Attorneys are in bed with known and admitted members of organized crime.

As a devout Catholic and 15 year member of the St. Lawrence Parish, I never thought I would hear myself say that.

The EXHIBITS for my previously filed MOTIONS FOR SUMMARY JUDGMENT and CHANGE IN VENUE are nearly identical.

For all other causes that may be fair and just.
