SECOND MOTION TO DISMISS

Now Comes Gerard Beloin, Pro Se, and respectfully requests that this honorable Court grant this SECOND MOTION TO DISMISS.

STATEMENT OF FACTS

1.

On February 27, 2009 there was a gun found in one of my 3 computer bags when I entered the Hillsborough County Court House. I did not know it was in the bag. We are currently trying to find out how that firearm got into the bag. The computer bag containing the firearm was stored behind the seat of my truck since September 2008. It had been in and out of the truck and I believe had not been used since early December, 2008.

2.

In August of 2005, I was indicted on multiple felonies of making and distributing illegal recordings and was facing the possible indictment on 20 more felony charges. As Pro Se, I got all of the felony charges reduced to misdemeanors. The multiple misdemeanors were then reduced to one misdemeanor. On June 9, 2006, the State defaulted and the charges against me were dismissed “with prejudice”. Against all precedent, and without any legal explanation, the charges against me were reinstated. My appeal has

been accepted by the NH Supreme Court and is pending. The recordings in question describe contract killings and a murder for hire scheme that predicts many more murders. The recordings are of Goffstown Prosecutor Kerry Steckowych sending a "personal messenger" to let me know in no uncertain terms what he plans on doing to me if I don't stop exercising my 1st Amendment rights. Following are excerpts from some of the recordings distributed to Hillsborough County Attorney Marguerite Wageling. Prosecutor Steckowych is a fellow prosecutor of Attorney Wageling and former candidate for Hillsborough County Attorney. Prosecutor Steckowych is currently the prosecutor for the Goffstown District Court

"They will watch for your car coming into Goffstown. They will stop you for no reason. They will dream up charges against you. They will treat you like a criminal." [\(EXHIBIT A page 2 of 8\)](#)

According to the recordings, everything is proceeding according to plan.

In another recording, Prosecutor Steckowych's "personal messenger" let's me know in no uncertain terms that because I dared to exercise my free speech rights, a hit contract has been issued on my life. Prosecutor Steckowych's "personal messenger" states that because I criticized Steckowych, "then you have no reason to get annoyed at me for moving ahead." They brag about how they murdered Dr. Hieber.

They brag about how they get rid of the dead bodies by dismembering them and chopping them up into little pieces and feeding them to the fish in the Atlantic Ocean from a "100 ft. f\*\*\*ing fishing boat." [\(EXHIBIT A page 8 of 8\)](#)

#### CONSPIRACY TO COMMIT MURDER.

In all of these recordings, both Prosecutor Steckowych's "personal messenger" and the Informant use the plural when describing my assailants. "These guys are afraid of you now". "They throw gas bombs through windows when they can't get in". "He's talking about chumming people."

All of these recordings prove beyond a shadow of a doubt that there is a conspiracy to

commit multiple murders. This is not my interpretation. It is there own statements. “They throw gas bombs through windows when they can’t get in” shows the method to commit murder and the willingness to commit multiple more. “He’s talking about chumming people” clearly shows a process by which they are disposing of multiple bodies and the method and willingness to murder and get rid of multiple more dead bodies.

In September of 2008, I decided to run for Hillsborough County Attorney. [I ran as a write in candidate and promised to clean up the corruption at the Hillsborough County Attorney’s Office.](#) My campaign commercials, widely viewed on the internet, were hard hitting, [accurate](#) and directly tied to these recordings and [Attorney Wagelings deaf, dumb and blind approach to them.](#) They are still available on the internet by [Googleing Gerard Beloin.](#) I let everyone know that I was challenging Attorney Wageling for the position again in 2010. My campaign promise is to investigate and prosecute these politicians and law enforcement officers, who, according to their own “personal messengers”, have committed the multiple crimes of

According to my documented records, this defendant can prove **68 counts** of perjury, suborning perjury and conspiracy to commit perjury by agents for the State of NH and its agents. None are being investigated. None are being prosecuted. The multiple acts of perjury are to cover up the much more serious crimes mentioned above.

All of the States previous attempts at framing me for crimes I did not commit failed. There is a pattern and practice here that can't be ignored. [Their motive for silencing me is painfully obvious.](#) These agents for the State are desperate. On February 9th, 2009, I posted the proof of these crimes on my blog. [\(EXHIBIT B\)](#) The next time I'm in court on February 27, 2009, a firearm is found in my computer bag while entering the Hillsborough County Superior Court House.

On the other hand, I, Gerard Beloin, had absolutely no motive for bringing a firearm into the court house on that date. The hundreds of MOTIONS, hearings and numerous trials were over. Except for my appeal accepted by the NH Supreme Court, my legal troubles were over. After years of being undefeated in the courtroom and with the light at the end of the legal tunnel nearing, knowingly bringing a firearm into the court house is anathema to everything I believe in and counterproductive to every action I have taken over the last few years.

I did not knowingly bring that firearm into the court house on that day. We are still trying to figure out how it got there.

All of the evidence documented in this SECOND MOTION TO DISMISS proves a motive for framing me for crimes I did not commit. It proves a willingness to do so. Recordings explain how they plan to do so. [\(EXHIBIT A page 2 of 8\)](#) And, to top it all off, court records with Prosecutor Steckowych's signature on them prove that he admits to being the progenitor of these recordings by suing to have them all destroyed. If the State of NH is hell bent on catching criminals, I have provided the state with a plethora of them to choose from in this SECOND MOTION TO DISMISS. I am not on that list.

- A. Grant this SECOND MOTION TO DISMISS.
- B. Schedule a hearing on this MOTION.
- C. Grant such other further reliefs as this court deems just.
