THE MISS STATEMENT OF THE CASE

On page 2 of the States Reply, the State MISREPRESENTS AND OMITTS the facts of the case and ignores the direct connection between this NH Supreme Court case and organized crime.

On October 7, 2009 this Defendant testified at a public hearing of the NH Executive Council. At that hearing I disclosed to the Executive Council a letter I received from an anonymous source, just after

my appeal was accepted by this NH Supreme Court. That letter contained a photograph printed from the internet. It was a photograph of several severed heads spread out on a floor. [\(APPENDIX A\)](#) That gruesome photograph is the modern day equivalent of a horses head in your bed. The message from “these guys” to this Defendant is that I need to stop exercising my legal rights or my relatives and I will suffer the same fate as the poor victims in the photographs. On that date, this photograph was forwarded to the NH Attorney Generals Office by the Chairman of the NH Executive Council, Councilman Raymond Burton. There has been no response from the NH Attorney Generals Office. My informants have told me that they are waiting for organized crime to do their job so that they won’t have to do theirs.

The State originally charged this Defendant with numerous counts of committing the crimes of prohibited interception and disclosure of an oral communication in that “Gerard Beloin did commit the crime of prohibited interception and disclosure of an oral communication in that Gerard Beloin did willfully (purposely) intercept an oral communication made by John Janigan, without his consent, and thereafter did willfully (purposely) disclose the contents of the oral communication to James DeHart, Deputy General Counsel, NH Supreme Court Attorney Discipline Board, knowing or having reason to believe that that information was obtained in violation

of RSA Chapter 570-A, by mailing a CD containing the contents of the oral communication to him.”

Since the New Boston School Board is part of the same SAU, this Defendant thought it would be a good idea for them to know how the SAU #19 handled complaints from its residents who dared to exercise their 1<sup>st</sup> Amendment rights by speaking out against members of the Goffstown School Board. The New Boston School Board refused to press charges.

The other count was for distributing the recordings to Hillsborough County Attorney Marguerite Wageling. That one was dropped for reasons unknown to me.

The last and only complaint left is by the **NH Supreme Court Attorney Discipline Office**. That is the only one that was prosecuted. Attorney DeHart was the only person willing to stoop this low and manhandle this tar baby of a case by pushing it all the way to the NH Supreme Court, where he works.

### STATE'S MISS STATEMENT OF THE FACTS

The State has used the perjured testimony of Mr. John Janigan, an admitted member of organized crime, to build its case against this innocent Defendant. [\(APPENDIX D – Transcripts of the 2008-11-13 trial - Pages 32, 33, 34\)](#)

Attached are the transcripts of all of the recordings in question. [\(APPENDIX E – Transcripts of all of the allegedly illegal recordings\)](#) The recordings begin at precisely 10:30am on 12-13-2004 and document the initial contact. I have the digital time stamp on the original recording. Mr. Janigan's testimony, under oath, at the trial, directly contradict his actual statements, recorded and contained on the CD of the recordings. [\(APPENDIX F – CD of the recordings\)](#)

The reasons why these recordings are perfectly legal are because Mr. Janigan called me on my cell phone at precisely 8:26am, 9:34am and 9:39am on 12-13-2004 [\(APPENDIX G – Phone records\)](#) and repeatedly threatened me with death on the orders of Prosecutor Kerry Steckowych. [\(APPENDIX H – Affidavit from Linda Beloin\)](#) Since Prosecutor Steckowych is the Victim and Witness Assistant for the Town of Goffstown, [\(APPENDIX C\)](#) I had no other recourse.

Mr. Janigan is committing perjury. That is a felony. The State has built their case on the testimony of a single witness who **knowingly** committed perjury during this Defendants trial. Mr. Janigan should be prosecuted and sentenced to 5 years in prison for his brazenly false statements made under oath and this case should be dismissed with prejudice for a second time. Instead, the State cites Mr. Janigan's perjured testimony as proof of this Defendants guilt.

Mr. Janigan's motivations for perjuring himself are legion because these recordings contain his admission of being a member of organized crime. He brags about his connections to organized crime ("these guys") and how they have infected law enforcement, the prosecution and the courts. Mr. Janigan knows people who "shoot" people. The proof and admission of the following crimes, admitted to on tape by Mr. Janigan, acting as an agent for Prosecutor Kerry Steckowych who is a member of organized crime masquerading as an agent for the State of NH.
